RESOLUTION IN SUPPORT OF EXISTING UPSTATE NUCLEAR POWER PLANTS AND NEW NUCLEAR IN OSWEGO COUNTY TO MEET GOVERNOR CUOMO'S CLEAN ENERGY STANDARD

WHEREAS, nuclear energy in Oswego County, NY is an essential source of carbon-free energy; and

WHEREAS, nuclear energy in Oswego County is an important component of the reduction of harmful carbon emissions; and

WHEREAS, the removal of even one operating nuclear power plant will result in the loss of ten percent (10%) of the state's carbon-free electrical generation; and

WHEREAS, the Town of Scriba has worked cooperatively with Exelon, Inc., the owners of Nine Mile Point Nuclear Generating Station Units 1 and Unit 2, and the Entergy Corporation, owners of the James A. FitzPatrick nuclear power plant, all currently located in the Town of Scriba to ensure safe and productive operation; and

WHEREAS, Oswego County is home to a skilled and dependable building and trades workforce that has vast experience in both the construction and operation of nuclear power plants; and

WHEREAS, Oswego County's natural resources and existing infrastructure are well-suited to support both continued and further development of nuclear power; and

WHEREAS, all citizens of the Town of Scriba and the regional community would benefit financially from both the continued operation of the Nine Mile Point Nuclear Generating Station Units 1 and 2 as well as the benefit that would be realized with the substantial expansion of the tax base from construction of a new nuclear power plant;

NOW, THEREFORE, upon motion duly made by Board Member Sheldon and seconded by Board Member Kennedy, it is and shall hereby be

RESOLVED, that the Town Board for the Town of Scriba expresses its support for the continued operation of the James A. FitzPatrick nuclear power plant and the Nine Mile Point Nuclear Generating Stations, Units 1 and Unit 2; and it is further

RESOLVED, that this body again urges full consideration of the Town of Scriba, and Oswego County as a site for any new nuclear facilities that may be developed to assist in meeting New York State's goals for reduction in carbon emissions; and it is further

RESOLVED, that, by copy of this resolution, our State and Federal representatives are requested to support its intent and to pursue the funding and the methods necessary to support new nuclear construction in Oswego County; and it is further

RESOLVED, that the Town Clerk of the Town of Scriba is hereby directed to transmit a certified copy of this Resolution to New York State Governor Andrew Cuomo, New York Public Service Commission Chair Audrey Zibelman, United States Secretary of Energy Dr. Ernest Moniz and United States Nuclear Regulatory Commission Chair Allison M. Macfarlane.
